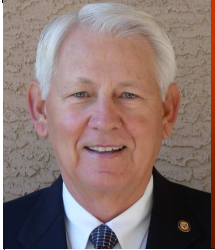

# Boeing Helicopter Plant Tour

## 20 February 2010

### Lunch to follow at McCormick Ranch



Highly maneuverable and heavily armed, the combat-proven Apache helicopter is today the backbone of the U.S. Army's all-weather, ground-support capability. The AH-64D Apache Longbow, which first flew as a prototype on May 14, 1992, provides a quantum leap in capability over the AH-64A. The Apache Longbow's fire-control radar and advanced avionics suite give combat pilots the ability to rapidly detect, classify, prioritize and engage stationary or moving enemy targets at standoff ranges in nearly all weather conditions.

## Boeing Helicopter Plant

A Chanen joint venture designed and built this \$107 million facility with fast-track construction, permitting completion and move-in within 19 months and saving \$10 million. The design-build, 1.3 million sq.-ft. expansion project consisted of office, laboratory and assembly facilities. Included were an assembly building, central plant, flight test facility, warehouse and a paint hangar.

The two-story, 340,000 sq.-ft. Advanced Development Center was built to serve as a giant laboratory for development of new rotocraft programs and advanced versions of the Apache AH-64 and Model 500 Series helicopters. The facility includes a 225,000 sq.-ft. engineering center, a three-story, 270,000 sq.-ft. corporate headquarters, a 17,000 sq.-ft. computer room, a 200-seat auditorium and a cafeteria. A 250,000 sq.-ft. material center contains a quality-assurance laboratory and warehouse.

This plant makes the AH-64 helicopters that were used in the Gulf War and Desert Storm.

**Donate Air Miles**

In response to a request from one of our members, I have researched opportunities for the donation of air miles for the use of service members and their families. I have discovered two opportunities as discussed below:

**Soldiers' Angels**

Soldiers' Angels is an international volunteer-led 501(c)(3) nonprofit organization providing aid and comfort to the men and women of the United States Army, Marines, Navy, Air Force, Coast Guard, and their families. With over 30 different teams and projects, its nearly 200,000 volunteers assist veterans, wounded and deployed personnel and their families in a variety of unique and effective ways. One way is to provide flights to soldiers on leave or in emergency situations, and to their families wanting to be with them upon return from overseas.

With Soldiers' Angels, the donor keeps title to the miles and makes the reservations for the approved traveler. All of the required information is at <http://soldiersangels.org>. Click on "Donate" in the Main Menu and go to "Airmiles".

**Hero Miles**

The non-profit Fisher House Foundation administers the "Hero Miles" program for the

Department of Defense. The program is comprised of individual airlines whose passengers donate their frequent flyer miles to assist service members and their families. Specifically, Fisher House Foundation provides free airline tickets to military men and women who are undergoing treatment at a military or VA medical center incident to their service in Iraq or Afghanistan, and their families.

There are two categories of eligible recipients:

1. Service men and women with an approved leave of five or more days may be given a free round trip airline ticket for travel from the medical center to their home and return if they are not eligible for government funded airfare.
2. Qualifying service men and women may be given free round trip airline tickets to enable their family or close friends to visit them while they are being treated at the medical center.

The request for tickets will ordinarily originate with the service member and be forwarded to Fisher House Foundation by the social work staff or family assistance center at a medical center, or through service casualty offices. Only under exceptional circumstances should family members contact Fisher House Foundation directly. With Hero Miles, the air miles from most of the airlines can be donated directly to Fisher House. Fisher House Foundation has written agreements with individual airlines that contain specific criteria for the use of the miles donated to the "Hero Miles" program. It is for this reason that the Foundation must ensure the

## Legislative Update

### State Budget—Familiar Story

As calendar year 2010 begins, Arizona begins the second half of its FY2010, which ends June 30. The Arizona Legislature is dominated by two factors: the budget, for which there is no apparent solution, and elections, which seem to provide little motivation for agreement on a solution. The latest round of budget cuts for FY2010 still leave a state deficit of over \$1 billion for the current fiscal year. FY2011, on which the legislature is supposed to be working, is even worse. So, don't expect any new state initiatives that cost money to surface for quite awhile.

The Arizona Department of Veteran's Services (ADVS) absorbed general fund budget cuts of \$600,000 for FY2010 so far. ADVS has absorbed this cut by delaying projects without significantly reducing services. The FY2011 budget proposal submitted by the Governor in January did not contain any more significant cuts for ADVS. However, the budget contained several factors, including a sales tax increase, that there does not appear to be any consensus on. Any further cuts for ADVS will surely result in some personnel reductions. The Director has gone on record indicating that Veteran Benefit Counselors, whose job it is to help veterans through the red tape of the VA process, will be the absolute last to be affected. We certainly hope that holds true.

The Arizona legislature began its FY2011 session on Monday, January 11. As *The Sentinel* goes to press there have been 34 bills introduced, eight in the Senate and 26 in the House, which have some impact on veterans, the military or their families. This compares to 28 we were tracking last year, of which about half a dozen actually got approved. A quick review of this year's list shows none that involve much money, several that are administrative in nature and several revived from last year's list. As the process continues we will begin to see which ones have promise for enactment this year and which ones we may wish to lend our support to.

### Meanwhile, at the National Level

On the national side we see similar budget and election year issues. MOAA has a well orchestrated set of goals identified depending upon how circumstances begin to play out. You can view the list at [www.MOAA.org](http://www.MOAA.org) or read a discussion on them in the January edition of the MOAA magazine. The next major event on the national legislative agenda, which will help MOAA prioritize actions, is the issuance of the President's FY2011 Defense Authorization budget, which is expected in early February. Last year, the big surprise was the absence of a continuing DOD proposal to significantly increase health care and pharmacy fees and co-pays. This year it remains to be seen.

### Medicare/Tricare Fees Still in Play

In the meantime, the most pressing issue for most of us is the pending Medicare/TRICARE doctor payment cap problem that we have been discussing for about four years now. Without further action by Congress and the President an existing, flawed law will result in a 21% Medicare/TRICARE pay cut to doctors on March 1. This is a really big deal in that it will most assuredly result in many more doctors refusing to care for Medicare/TRICARE recipients. Also, it is a \$250 billion problem for the Congress to deal with. We believe that Congress had planned to address this as a part of the national health reform. However, with that now in limbo, separate action now appears vital on this Medicare/TRICARE payment to doctors issue. ### February: A Historic Month for Arizona

February figures prominently in our state's history. While Arizona became the 48th state on February 14, 1912, that wasn't the only time February 14 figured in the state's history. Jefferson Davis, president of the Confederacy, proclaimed Arizona as the Confederate Territory of Arizona on that date in 1861. President Abraham Lincoln trumped that action when he signed a law establishing the Arizona Territory on February 24, 1863. Thus it remained until 1912.

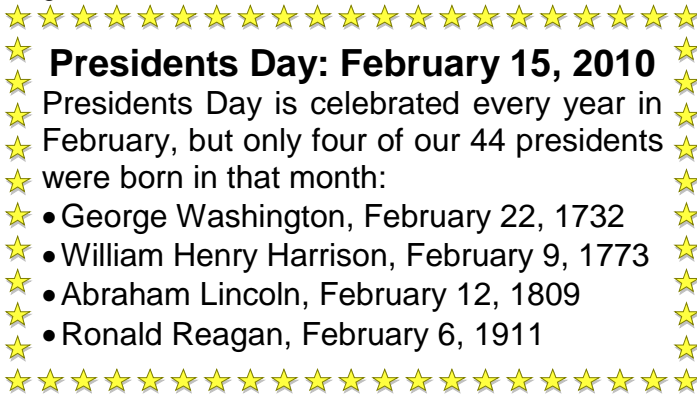
