In a recent Legislative Update from MOAA National, they reminded us to "Thank a Deserving Legislator". With the FY2005 National Defense Authorization Act comes a series of victories for our military and military retirement communities. Among those are a 3 1/2 year phase-out of the SBP "widow tax", significant strides on Guard and Reserve healthcare and permanent ID cards, and full concurrent receipt of 100% disabled retirees starting in January. While it may not yet be perfect and certainly many challenges remain, this act marks a significant improvement over where we were. ## Origins of Veterans Day

In 1921 an unknown World War

I American soldier was buried in Arlington National Cemetery. This site became the focal point of reverence for America's veterans. Memorial ceremonies took place annually on November 11, recognizing the ending of World War I fighting at the 11<sup>th</sup> hour of the 11<sup>th</sup> day of the 11<sup>th</sup> month. This day became known as Armistice Day by Congressional resolution in 1926 and became a national holiday 12 years later.

If the idealistic hope had been realized that World War I was the "War to end all Wars," November 11 might still be called Armistice Day. But only a few years later war broke out in Europe. Sixteen and one-half million Americans took part. Four hundred seven thousand of them died in service, more than 292,000 in battle.

Realizing that peace was equally preserved by veterans of World War II and Korea, President Eisenhower signed a bill in 1954 proclaiming November 11<sup>th</sup> as Veterans Day. On Memorial Day in 1958 two unidentified American war dead, one from WWII and one from the Korean War, were brought from overseas and interred beside the Unknown Soldier from WWI.

In 1973 a law passed providing interment of an unknown from the Vietnam War, but none was found until 1984. To honor these men,

**Chapter & National MOAA Memberships**

There continues to be a lack of understanding of how local Chapter dues and National MOAA dues are handled. Lets be clear – **THEY ARE TWO SEPARATE AND DISTINCT DUES.** AZ Chapter bylaws required all Regular Chapter members to also hold and maintain membership in the National Military Officers Association of America. While not required, all Auxiliary members are also encouraged to acquire and maintain National MOAA membership. This year, cost is \$20.00 for Regular members and \$10.00 for Auxiliary members per year for Chapter dues. This is in addition to the annual National MOAA dues that are paid directly to National MOAA when 'billed'. The number system used on Chapter newsletter mailing labels (i.e., 04, 05, etc) refers only to paid up local Chapter dues. The Chapter membership year runs from 1 January to 31 December. If you are a life member of National MOAA you are recognized by MOAA with a life membership card. If you are a yearly member of National MOAA your membership runs for 12 months from the date you originally subscribed. Do not send your National dues to our local Chapter – send them to National MOAA!

**Chapter Legislative Committee**

**Legislative**

There is great news for retirees in the proposed FY 2005 Defense Authorization Act, pending signature and approval by the President.

**SBP** - The first is that it includes provisions to eliminate the social security offset under SBP by increasing the annuities paid to survivors of military retirees who are 62 or older from 35 percent of retired pay to the percentages indicated below:

For months after September 2005 and before April 2006: 40 percent

For months after March 2006 and before

April 2007: 45 percent

For months after March 2007 and before April 2008: 50 percent

For months after March 2008: 55 percent

**Concurrent Receipt** - The second is that those 100% disabled will receive 100 % concurrent receipt. Currently, the law provides for Combat Related Special Compensation for those with 10 % to 100% disability, and a 10 year phase-in of Concurrent receipt of those with 50% or more disability which is not combat related. This leaves the government with the virtually impossible task of identifying those whose disabilities are combat related. I know that some are receiving the compensation to which they are entitled, but others are still waiting.

The result is that those with up to 50% disability are entitled to only the Combat related compensation; those between 50% and 90% combat related are entitled to the greater of the combat related compensation and the 10 year phase in of concurrent receipt; those between 50% and 90 % not combat related are subject to 10 year phase-in; and the 100% disabled are entitled to full concurrent receipt, whether or not combat related. There were to be no more changes until disability standards were established by a Disability Commission. So far, the Disability Commission has not been completely formed. Even so, the change for the 100% disabled was made. With no action on the Commission, possibly we can expect others to be exempted from the 10 year phase-in.

Other legislative gains during the 2003-2004 Legislative session are as follows:

**Health Care** - Won Requirements for TRICARE Standard Improvements.

Won TRICARE Coverage for Selected Reserve Mobilized Since 9/11. Extended Pre and Post-Call-up TRICARE Coverage Period for Guard / Reserve.

Waived Medicare Part 'B' Late Enrollment Penalty for TFL-Eligibles. Authorized Long Term Care Insurance Coverage for 'Gray Area' Reserves.

**Retirement/Survivor Issues** - Ended Retired Pay Offset Associated with Any Combat/Ops-Related Disability. Authorized Permanent ID Cards for Spouses/Survivors Age 75 and Older. Doubled Death Gratuity to \$12K and Indexed to Pay Raises. Won SBP for Guard/Reserve Drill-Duty Deaths. Restored DIC for Survivors Who Remarried After Age 57. Authorized One-Year Open Enrollment Window for SBP (Starts Oct 1, 2005).

**Active/Reserve/Force Issues** - Cumulative 7.8% Pay Raise for Active Duty, Guard / Reserve for 2004-05. Indexed Military Pay Raises to Private Sector Wage Growth (Begins 2007). Won 20,000 Increase in Army Force Levels for 2005; More in Outyears. Won Capital Gains Tax Relief for Military Homeowners. Improved Legal Protections for Mobilized Guard / Reserve Under SCRA. Restored Tax Deduction for Guard / Reserve Drill-Related Expenses. Won Permanent Increases in Family Separation Allowance and Danger Pay. Won New Commissary Benefit Protections. Won Full Commissary Benefits for Drilling/Gray Area Guard / Reserve. Defeated Proposals for Commissary, Dependent Schools Cutbacks.

**Veterans and Other Issues** - Burial in a National Cemetery for Remarried Surviving Spouses of Veterans. Authorization for Five New National Cemeteries. Permanent VA Home Loan Authority for Reservists. 31% GI Bill Educational Benefits Increase for Active Duty Recruits. Increased Survivors / Dependents VA Education Benefits.

I hope that you will agree that MOAA is a real force in Washington, but they are the first to say that Chapter and Member support are what makes them effective.

#### Other Actions:

**COLA** - The Bureau of Labor Statistics released September's inflation data, which finalizes the 2004 cost of living adjustment (COLA) for military retired pay and other federal annuities. The 2004 COLA will be 2.7 percent for military and federal retired pay, VA disability compensation, SBP survivor annuities, Social Security, and other

f e d e r a l p r o g r a m s . The COLA for these programs will be effective December 1st, and will be reflected in checks issued on January 2, 2005.

**New Reserve Reemployment Rights Rules** - Responding to concerns over the rising number of reemployment rights claims of returning Guard and Reserve combat veterans, the Department of Labor's Veterans Employment and Training Service (VETS) has published new rules to explain the Uniformed Services Employment and Reemployment Rights Act (USERRA).

USERRA protects the rights of workers who leave their civilian jobs for military service and bars employers from discriminating against them because of their military service or obligations. The law protects both voluntary and involuntary military service. Under the proposed regulations, employers would be required to restore the pay, seniority rights and other benefits as if he reservist employees had never left the workplace for military duty.

The new rules are presented in a user-friendly, plain language style in a question and answer format. The introduction section cites several important case law examples to help users interpret how the law is to be applied.
