President's Message

As I had reported previously, our application for 501(c)(3) status for the Scholarship Fund has been approved by the Arizona Corporation Commission and we are now in the process of the required publication of our Articles of Incorporation and in the filing of our Articles of Incorporation with the IRS. Also as I had reported previously, the 501(c)(3) status will allow us to expand our charitable request activities. We have decided to terminate the Silent Auction because of lack of interest over the past two years.

Our thought is to solicit \$1,000 donations from local businesses and individuals to sponsor a specific scholarship. The idea is that the sponsor would be invited to our annual scholarship luncheon and participate in the presentation. We would continue to solicit donations from our members with the hope that we would be able to sponsor a scholarship which we could call the "Arizona Chapter Scholarship".

missed opportunity to mind. First, in discussing this benefit with a number of members, few if any knew it existed. Second, when estate planning speakers tout their services and the costs range from \$1000 to \$5000, a 25% discount is a substantial savings.

MOAA annually publishes a list of lawyers throughout the U.S. who have agreed to reduce the cost of legal services to fellow MOAA members. Members are assured of the high quality of legal services since the national organization screens all lawyers before it adds them to its national list.

How do you find such a lawyer? Once a year the national magazine, *THE MILITARY OFFICER*, publishes the lawyer list. If you don't have it, you can call MOAA headquarters (800-234-6622) and ask for a lawyer in your area. Or if you have internet access, type in www.moaa.org and look for the member benefits link in the left hand column. Under that heading, open up "Products/Services". That will take you to all sorts of member benefits at reduced prices: hotels, car rentals, products to purchase and legal

Editor's Notebook

Gone 'phishing' - the E-mail scams just keep on coming.

Business must be good for the scammers as my E-mail in basket has runneth over this past month with urgent messages directing me to web sites where I need to enter my account number.

They only wanted to verify information so that I, as one of their customers, will not be ripped off by some crook who has been trying to access my account. The letters looked so legitimate and read so well

one might be tempted to do what they ask. That is, if one wasn't aware of such scams and if one happened to have an account with that bank.

The latter is what makes some of the attempts seem so pathetic. Messages from a number of different banks directed at E-mail addresses they pinged from the Internet. I ask you, how many people do their banking from their place of employment?

On second thought, scratch that one. I'll rephrase my question: How many people give banks their office E-mail address, especially one such as old.retiree@abcd.yahoo.mil? And how can these "phishers" be so dumb as to send E-mail messages to folks who don't have accounts with their banks? The answer, unfortunately, is because there are so many people who don't stay abreast of such scams.

An FBI official was quoted in our local paper recently that a "phisher might send out 100,000 E-mail messages and only get 25 or fewer bites, but that's enough to make money. Multiply the 100,000 by 10 times, which is not

uncommon for a single scammer I'm told, and it adds up to a considerable number of bites.

Personally, in just over a week, I've received scam mails supposedly originating from the Regions Bank (three of them); South Trust Bank and a half dozen of them from Washington Mutual.

Let me add now the information presented here isn't aimed at the subscribers to this newsletter because you know better. It's aimed at folks you know who may not keep up on the latest fraud alerts. You know who they are so anytime you hear or read about a new scam, pass it along.

One of the pieces of advice I always include when telling someone about a "phishing" expedition is that if you really think it sounds good, and you really do want to nibble on the bait, check with the financial institution's web site. Just don't go to the site as it is listed in the E-mail message because, if it is a scam, it will have an address that looks legitimate, but will have an embedded address directing the flow of the search. I know hardly anything about computers and even I can do that.

Go to one of the search engines such as Google or Yahoo and type in the financial institution in question. I did that after receiving several messages from Washington Mutual about "my account" that I don't have with them. That financial institution is well aware of these scams and has warning messages all over the place with a lot of good and legitimate suggestions about how not to get ripped off.

I would devote more time to this but I just received a note in my old.retiree@abcd.yahoo.mil in basket from aw-verify@eBay.com notifying me that "we regret to inform you that your eBay account has been suspended due to the violation of our site policy below:" Certainly, I'll just rush out and go to the web site they give to straighten this out. **Sure!!**

Legislative Chairman's Notes

The legislative front continues its litany of good news and bad news. On the bad news side, the severe constraints of the President's FY06 budget are becoming increasingly clear. For example, at our March meeting of the Unified Arizona Veterans (UAV), Pat Chorpenning, Arizona Department of Veteran's Services Director, lamented the impacts of the fiscal year 2006 VA budget on the Arizona state VA programs.

This budget of \$70.8B includes \$37.4B in mandatory funding for compensation and pensions, \$30.7B for medical care and \$2.7B in other discretionary funding. Among the impacts is no new Priority Group 8 veterans will be permitted to enroll. Priority Group 7 and 8 veterans would pay an annual enrollment fee of \$250 and an increase in prescription co-payments from \$7 to \$15. The VA would no longer maintain an annual census of inpatient beds for long-term care and mental health patients at the current levels. The VA would reimburse state homes only for care for veterans who meet certain criteria. Shortfalls in federal budget support to the states are particularly acute, and Mr Chorpenning and his staff are struggling to maintain as many services as possible, but cuts are inevitable.

On the good news side, our Congressmen continue to press forward on many new bills that would benefit both active and retired military members. Bills that would improve active duty survivor death benefits including SGLI and death gratuity continue to progress well. MOAA and the military coalition continue to press for a variety of other benefit improvements as well.

Chuck Schluter and I will be representing MOAA Arizona Chapters at MOAA's annual Council President's Seminar held April 5-8 in the Washington D.C. area. In the highlight of the seminar, we will participate in a Storming the Hill

session. During this one-day lobbying blitz, members of the national board of directors and MOAA's national staff will accompany state council leaders as they meet with their elected representatives and their staffs on Capital Hill. We will work to persuade legislators to cosponsor and enact legislation to end the unfair dollar-for-dollar offset of Dependency and Indemnity Compensation (DIC) against military Survivor Benefit Plan (SBP) annuities and to accelerate the effective date of paid-up SBP to Oct 1, 2005.

We also will attend a MOAA sponsored reception on Capital Hill. During the reception, the association will present its annual leadership awards to those who worked hard during 2004 to pass legislation that helps military members and their families.

During the final day of the seminar, we will attend a Cross-talk session where we will have an opportunity to share our thoughts, ideas, and problems with other council leaders. The seminar also will include two benefits information workshops and a briefing about how to recruit more active duty and Guard and Reserve members as well as an update on TOPS.

In addition, the winners of the 2004 Communications Awards contest will be announced. The contest is conducted annually by MOAA's Department of Council and Chapter Affairs to recognize councils and chapters that have outstanding print newsletters, electronic newsletters and Web sites. As you probably recall, last year our chapter brought home top awards in our class in this competition.

In other news worthy of note, bills have been introduced in Congress that would allow certain insurance premiums to be paid with pre-tax dollars. They would affect active and retired service members and survivors who pay Tricare Prime enrollment fees, Tricare Standard supplemental insurance premiums

and Tricare dental premiums.

If you use the DFAS website and didn't see the announcement, a change is afoot. As of March 1, the website went from www.dfas.mil to www.dod.mil/dfas. Users who go to the old website as of April 1 will be automatically redirected to the new site for an unspecified introductory time.

Finally, the 2005 edition of "Federal Benefits for Veterans and Dependents" is now available on line. It is an 840 KB PDF that requires Adobe Acrobat (4.0 or later) or other PDF viewer. The document can be accessed through the "Current Benefit" link at the bottom of the VA Home page) <http://www.va.gov>.

Board Meeting Notes

The Board of Directors met on 3 March 2005 at American Legion Post 107.

The following items of interest were considered.

- ◆ **Legislative:** Referring to March 2005 issue of *Military Officer* magazine, we encourage members to sign and stamp the two post cards found on the outside cover of the magazine. It is too early in the congressional session for legislative action however bills have been introduced to increase the values of insurance policies. Two goals: repeal the SBP-DIC offset and move up the effective date of paid-up SBP premiums to October 2005, are still being pursued. DFAS is changing their web site address to www.dod.mil/dfas as of March 1, 2006. **Chuck Schluter** and **Gary Fredricks** will attend MOAA's annual council Presidents' Seminar, April 5-8, 2005. Appointments have been requested with the Arizona Congressional Delegation. Members that have suggestions for MOAA contact Gary before they leave for the seminar.
- ◆ **Treasurer's Report:** Indicated assets of \$16, 486.73.
- ◆ **Membership:** **Davis Rohr** will assume the duties of Membership Chairman after the April BOD Meeting. **Chuck Schluter** will ask MOAA to send an updated list of MOAA members residing in our area. We still have three Chapter members that are not members of MOAA – we will revisit this issue at the May BOD Meeting.
- ◆ **JROTC Medals:** **Art Parker** has indicated that we still need volunteers to present JROTC awards during the month of May.
- ◆ **Open Positions:** A motion was made, seconded and approved to name **Davis Rohr** 2nd Vice President replacing **Bernard Katz** who had resigned the position. The Secretary will notify MOAA of the change. **Terry Tassin** will continue as editor of the newsletter and **Dan Conway** will continue to transport/store the flags as the membership has stepped forward in ensuring that the flags are set-up and taken down at the meetings.
- ◆ **National Awards, Levels of Excellence Application:** **Dan Conway** will document Efforts and Results on Legislative Achievements and **Ron Green** will document Efforts and Results on Membership.
- ◆ **General Meetings:** Due to a low level of attendance at the evening dinner meetings a motion was made and seconded to abandon the evening meeting and schedule the monthly meetings as a Saturday Luncheon. Some special events may be more suited to an evening dinner. Location of the new Saturday Luncheons will remain at McCormick Ranch Golf Club in Scottsdale. The motion was approved.
- ◆ **Status of 501(c) (3) Application:** The application has been approved by the Arizona Corporation Commission. The next step is to publish the application three times in the *Capital Times*. Once that is completed, we will apply to the IRS.
- ◆ **Fund Raising:** We will attempt to get five corporations to sponsor scholarships in the amount of \$1,000 each. **Dan Conway** will compose a fund raising letter and would like recommendations of corporations to contact.

More Real, True and Un-Exaggerated Rules of Golf

- There are two kinds of bounces: unfair bounces, and bounces just the way you meant to play it.
- You can hit a 2-acre fairway 10% of the time, and a 2-inch branch 90% of the time.
- Every time a golfer makes a birdie, he must subsequently make two triple bogeys to restore the fundamental equilibrium of the universe.
- If you want to hit a 7-iron as far as Tiger Woods does, simply try to lay up just short of a water hazard.
- To calculate the speed of a player's downswing, multiply the speed of his back swing by his handicap. Example: back swing 30 mph, handicap 20, downswing 600mph.
- There are two things you can learn by stopping your back swing at the top and checking the position of your hands: how many hands you have, and which one is wearing the glove.
- Hazards attract; fairways repel.
- You can put "draw" on the ball, you can put "fade" on the ball, but no golfer can put "straight" on the ball.
- A ball you can see in the rough from 50 yards away is not yours.
- If there is a ball in the fringe and a ball in the bunker, your ball is in the bunker.
- If both balls are in the bunker, yours is in the footprint.
- Don't buy a putter until you've had a chance to throw it!
