She is Commander of the Arizona National Guard Joint Counter Narco-Terrorism Task Force, the third largest National Guard counter-drug program in the U.S.

In addition to that program, Col Nelson is Commander of Operation Copper Cactus, the recent deployment of 560 soldiers and airmen in Arizona to support the Border Patrol and Immigration and Customs Enforcement. She also oversees the substance abuse testing program within the Arizona National Guard.

A Great Day to Hit the Links, Win Prizes, Support Scholarships

The next MOAA Golf Outing will be held **April 8** at Painted Mountain Golf Club in Mesa. The fee is \$65, which includes hole and flight prizes, food and golf plus cart. Per tournament director Pat Dale, the correct shotgun tee time is 7:30 a.m., NOT 6:30 a.m. as was indicated in a notice sent earlier. Check-in between 6:30 and 7:10.

Fees must be received in advance, checks written to **AZ Chapter MOAA** for \$65 per player and sent to Pat Dale, 12633 E. Kalil Dr., Scottsdale, 85259, phone 480-661-5204, e-mail patrickdale1@cox.net. We request all checks be received by March 25 if possible.

Groups and couples are encouraged, but not necessary. Coffee will be served before tee time, buffet lunch after golf. There will be four flights with 18 total winners, evenly spaced and based on raw score, plus a ladies flight.

Skill prizes will be awarded on all holes (closest to pin on par 3s, two longest drives and longest putt made on par 4s and 5s). The format is a "shamble" as we have done in the past, where all players hit the tee shot, then select the best one, all dropping there. Each player then plays his/her own ball from there, recording his/her own individual score for the hole. There will be a \$1,000 hole-in-one on hole # 2, plus some other extra prizes sold with proceeds going to winners and the JROTC scholarship fund. Those wishing to eat and not play golf will pay \$12, with those checks also going to AZ Chapter MOAA, mailed to Pat. Come and bring friends.

Memorable Life in Aviation Recalled by January Guest Speaker

Capt. Billy Walker, retired senior airline pilot, recounted his fascinating life of over 50 years in the air, which he likened to “a history of aviation,” at the January luncheon.

That life came naturally, as his parents were both aviation pioneers in Wyoming, and he soloed at 16. Since then, he has piloted 200 different kinds of aircraft, accumulated 40,000 hours of flying time and acquired multiple ratings and certifications. His early mentors were a “who’s who” of aviation, including FDR’s son Elliott Roosevelt and Arthur Godfrey.

Walker’s exploits included two years flying during the Vietnam War for Air America, the CIA airline. He was based in Cambodia, but said he couldn’t be called American because according to U.S. officials, “there were no Americans in Cambodia.” His stops included Laos, Vietnam, Thailand and Singapore. He flew a C-131 with no markings, since American markings couldn’t be used. Air America’s motto was, “Anything, Anytime, Anywhere, Professionally. First In, Last Out.”

His most memorable flight, Walker said, began on September 14, 2001. He was in France to deliver a new Jet Blue airliner to the U.S. It was three days after the World Trade Center tragedy, and he was able to fill the plane with Americans trying to get home. He recalls a moving sight on takeoff as he saw a huge American flag draped from a building and French citizens on the ground cheering.

He flew to New York City and at the last minute received clearance to land at JFK Airport, the first aircraft to land there since the

airport was closed on 9/11. The normally bustling airport was eerily quiet, he said. “The only thing moving was us.”

Walker, who will be inducted into the Arizona Aviation Hall of Fame in March, is a past wingman of the Lafayette Escadrille d’Arizona,

a patriotic group that flies World War I vintage aircraft in flyovers at public events, including the Memorial Day observance at the National Cemetery in Phoenix. “Our primary mission,” he said, “is to honor the veterans.”

Fiduciary Services

Just over a year ago, I wrote about Marie Long, who was taken advantage of by the County Probate Court system, and pointed out the availability of The Fiduciary Division of the State of Arizona, Department of Veterans' Services. Her problems continue. Therefore, I believe it prudent to provide more information about the Fiduciary Division. The following was taken from the web site of the Department of Veterans' Services:

Mission Statement of The Fiduciary Division
"To protect incapacitated veterans from exploitation and improve their quality of life."

The Fiduciary Division of the State of Arizona, Department of Veterans' Services, manages a program that serves as guardian, conservator, or representative payee for incapacitated veterans or the surviving spouses and dependent children of protected veterans pursuant to A.R.S. § 14-5414. A person is judged to be incapacitated if he or she is impaired due to mental illness, mental deficiency, physical disability or illness, senility or advanced age, drug abuse to the extent that the individual fails to exhibit sufficient understanding or ability to make sound or responsible decisions regarding his or her person or estate. Veterans are referred to the Fiduciary Division from a variety of sources, including the U.S. Department of Veterans Affairs, Regional Office and Medical Centers, Adult Protective Services, Arizona State Hospital, nursing homes, assisted living facilities, family members and, occasionally, veterans themselves. When a referral is made, the case investigator will visit the individual referred to determine if the Fiduciary Division can provide the services that are needed by the client. After the visit and upon determination by the program staff that the Fiduciary Division can serve the client, the County Superior Court is petitioned to gain appointment as guardian or conservator. A guardianship appointment involves assuming responsibility for ensuring the client's physical and medical needs are met. A conservatorship appointment involves assuming the responsibility

for managing the client's estate. The human service specialist assigned to the client carefully assesses his or her needs in order to secure medical, psychological and social services, training, education, and other services as appropriate in order to maximize the client's potential for self-reliance and independence. The Fiduciary Division also provides assistance to eligible veterans and their families in all financial matters, including powers of attorney, financial planning, budgeting, bill paying, preparing income tax returns, and making major purchases (e.g., homes and vehicles, etc.); and also acts as personal representative for the estates of deceased veterans and their spouses or dependent children.

Legislative Update

End of Year Activity

Last year ended with a flurry of activity by the lame duck congress which:

- Passed a stripped down version of the FY2011 Defense Authorization Bill;
- Passed a bill delaying a required cut in MEDICARE and TRICARE payments for doctors until January 2012, when it would then be a 25% cut;
- Approved funds for government operations until March 2011;
- Extended and augmented the Bush-era tax cuts.

Coming Up

Looking at this year, MOAA National has provided us an estimated timeline when important actions should occur as follows:

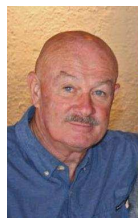
- Mid-February: The President submits his annual budget proposal to Congress. At this time we will see what the Pentagon proposes for military manpower levels, TRICARE fees and more. It will most likely be strongly influenced by the Deficit Commission Report of last year.
- Late March: Congressional Committees are required to submit their "views and estimates" of spending and revenues to the House and Senate Budget Committees six weeks after the President delivers his budget to Congress. We are likely to see some more impacts of the Deficit Commission report here.
- April: The House and Senate Budget Committees draft concurrent resolutions on the budget, which sets spending limits for the year.
- May: The House and Senate Armed Services Committees begin work on the FY2012 Defense Authorization Bill, including any changes that may be imposed by budget resolution spending limits.
- May-July: The full House and Senate should pass their respective versions of the defense bill. The last couple of years the House has made this schedule and the Senate hasn't come close.
- July-October: The House and Senate negotiators resolve differences between their

respective versions. This occurred in late December in 2010.

- October-December: The final FY2012 Defense Authorization Bill is passed by both the House and Senate and becomes law upon the President's signature.

MOAA's Focus

MOAA's legislative game plan will be a work in progress until after we see the President's budget proposal. That will focus MOAA's legislative initiatives on the most crucial issues. The remainder of the year will be pretty much working with congressional members to protect the interests of the military (including the Guard and Reserve), retired service personnel, their families and survivors.
